ORDINANCE NO. 97-03 Grant Township, Keweenaw County, Michigan

AN ORDINANCE TO REGULATE THE SPEED OF VESSELS ON THE WATERS OF LAC La BELLE AND THE CONNECTING CHANNEL, GRANT TOWNSHIP, KEWEENAW COUNTY, MICHIGAN.

THE TOWNSHIP OF GRANT ORDAINS:

In accordance with the provisions outlined in this Grant Township Ordinance No. 97-02, and Regulation No. 42, as defined by the Michigan Department of Natural Resources designation WC-42-97-01 – LAKE LAC LA BELLE (connecting channel) SLOW – NO WAKE SPEED,

<u>Section 1.</u> <u>Definitions.</u> "Operate", "Slow - No Wake Speed" and "Vessel" carry the same definitions as are assigned to said terms in the Natural Resources Environmental Protection Act, the same being P. A. 451 of 1994, Part 801-MARINE.

<u>Section 2.</u> No Wake - Speed Required. On the waters of Lake Lac La Belle and the connecting channel, Grant township, Keweenaw county, state of Michigan it is unlawful for the operator of a vessel to exceed a slow--no wake speed in the following areas:

- a) From the state access site to the opening of Lake Lac La Belle in section 32, range 29 west, town 58 north
- b) In the channel from the opening of Lake Lac La Belle to the end of the breakwall in Lake Superior, section 34, range 29 west, town 58 north.

The boundaries of the area described immediately above shall be marked with signs and with buoys. All buoys must be placed as provided in a permit issued by the Department of Natural Resources and be in conformance with the State Uniform Waterway Marking System.

<u>Section 3</u>. <u>Penalties.</u> Any person violating the provisions of this Ordinance shall, upon conviction, be subject to a fine not to exceed \$100.00 or imprisonment in the County Jail not to exceed ninety (30) days, or both such fine and imprisonment.

<u>Section</u> 4. <u>Ordinances in Conflict</u>, All ordinances and parts of Ordinances in conflict with the provisions of this Ordinance are, hereby repealed insofar as the conflicting portions thereof are concerned.

<u>Section 5.</u> <u>Publication and Recording,</u> This Ordinance shall be published in full in a newspaper of general circulation within the Township of Grant, said publication to be made within thirty (30) days subsequent to the passage of this Ordinance. This Ordinance shall be

recorded in the Ordinance book of the Township and such recording authenticated by the signatures of the Township Supervisor and the Township Clerk, said recording to occur within one (1) week after publication of the Ordinance.

<u>Section 6.</u> <u>Effective Date.</u> This Ordinance shall become effective on the 31st day following publication of said Ordinance.
